Whereas, resurgence of SARS-CoV 2 has been noticed in many parts of India and some areas of the State;

And whereas, **a virulent variant of COVID-19** is reported to be observed in people in Andhra Pradesh and Telangana;

And whereas, COVID appropriate behavior and protocols are required to be observed scrupulously in order to prevent the transmission of the infection;

Therefore, with a view to ensuring strict social distancing and isolation to contain the spread of COVID-19 pandemic, the Government of Odisha in Revenue & Disaster Management (Disaster Management) Department, in exercise of the powers conferred under Section 24(I) of the Disaster Management Act, 2005 read with Rule 8(1) of the Odisha Disaster Management Rules, 2010, do hereby issue the following directions (to Collector Ganjam, Gajapati, Rayagada, Koraput, Malkangiri, Nawrangpur):

- 1. Collectors of Ganjam, Gajapati, Rayagada, Koraput, Malkangiri, Nawrangpur are hereby directed to put Border Check Posts (BCP) on all inter-State roads (NH, State roads and local roads) along Andhra Pradesh and Telangana border with immediate effect.
- 2. The District Administrations shall ensure border tracking for all the major and minor entry points for incoming people from State of Andhra Pradesh and Telangana adjoining their districts to the State of Odisha. Adequate police arrangement may be made for such tracking.
- 3. Anyone coming to Odisha from Andhra Pradesh and Telangana by personal / hired vehicles (two-, three- or Four-wheelers)/ trains or entering the state in any other mode shall undergo **mandatory institutional quarantine for 14 days in Cluster TMC** to be managed by BDO/ EO of Urban areas.
- 4. The District Administrations shall ensure appropriate facilities and logistic support to Cluster TMC. Such CTMCs shall be operated as per guidelines of SRC office.
- 5. People travelling from Andhra Pradesh and Telangana to other States through Odisha shall be allowed without disembarking from the vehicle en-route inside Odisha.
- 6. Sarpanch(s)/ Ward Member (s) of PRIs & volunteers shall be mobilised to create awareness in their areas and further report to BDO/Police Station/ Local Authorities about any person coming from Andhra Pradesh and Telangana not quarantined in institutional facilities.
- 7. All passengers coming from Andhra Pradesh and Telangana alighting at Bhubaneswar/ Jharsuguda Airport/ any railway stations in the State, shall be mandatorily subjected to institutional quarantine/ paid quarantine for 14 days at facilities identified/ ordered by

District Magistrate/ Municipal Commissioner or any officer duly authorised on his/her behalf.

8. Any person(s) who has been successfully vaccinated (two doses) and produces certificate to the effect or tested negative (-ve) in RTPCR test (report to be produced) within 48 hours before entering Odisha, may be allowed home quarantine for 7 days. If there is no suitable facility for home quarantine, he/ she may opt for institutional / paid quarantine in identified facilities for 7 days.

However, in case of non- compliance of the Covid protocols and home quarantine guidelines issued by MoHFW/ H &FW Department of Government of Odisha, such persons shall be quarantined in institutional facilities **for 7 days**.

- 9. Persons coming on emergency works related to Covid-19 management by Government and private hospitals as well as those coming in connection any work permitted by Government of Odisha shall be exempt from this order. However, such persons shall strictly follow appropriate Covid-19 protocols and shall perform minimum necessary travel as would be required to perform the task for which he/ she has been drafted for & not unnecessarily move around.
- 10. Transport Commissioner, Odisha shall provide necessary assistance & guidance to District Collectors in operationalising the Border Check Posts.

Any person violating these measures will be liable to be proceeded against in accordance with the provisions of Section 51 to 60 of the Disaster Management Act, 2005, the Epidemic Diseases Act, 1897 and Regulations issued there under besides taking legal action under Section 188 of the IPC and other legal provisions as applicable.

<u>ORDER</u>

Order No.2116/ R&DM(DM) dated 22.04.2021 issued by this Department stands partially modified with the following ammendments in Clause- (3), (7) & (8) and inclusion of Clause-(9):

- 3. Anyone coming to Odisha from West Bengal by personal / hired vehicles (two-, three- or Four-wheelers)/ **trains** or entering the state in any other mode shall undergo mandatory institutional quarantine for 14 days in Cluster TMC to be managed by BDO/ EO of Urban areas/ or in an identified paid quarantine, if available.
- 7. All passengers coming from West Bengal alighting at Bhubaneswar/ Jharsuguda Airport/ **any railway stations in the State,** shall be mandatorily subjected to institutional quarantine/ paid quarantine for 14 days at facilities identified /ordered by District Magistrate/ Municipal Commissioner or any officer duly authorised on his/ her behalf.
- 8. Any person(s) who has been successfully vaccinated (two doses) and produces certificate to the effect or tested negative (-ve) in RTPCR test (report to be produced) within 48 hours before entering Odisha, may be allowed home quarantine **for 7 days** instead of 14 days. If there is no suitable facility for home quarantine, he/ she may opt for institutional / paid quarantine in identified facilities **for 7 days**.

However, in case of non compliance of the Covid protocols and home quarantine guidelines issued by MoHFW/ H &FW Department of Government of Odisha, such persons shall be quarantined in institutional facilities **for 7 days**.

9. Persons coming on emergency works related to Covid-19 management by Government and private hospitals as well as those coming in connection with election duty as per the orders of ECI or Chief Electoral Officer, Odisha shall be exempt from this order. However, such persons shall strictly follow appropriate Covid-19 protocols and shall perform minimum necessary travel as would be required to perform the task for which he/ she has been drafted for & not unnecessarily move around.

All other stipulations laid down in Order No. 2116/ R&DM(DM) dated 22.04.2021 remain same.

Any person violating these measures will be liable to be proceeded against in accordance with the provisions of Section 51 to 60 of the Disaster Management Act, 2005, the Epidemic Diseases Act, 1897 and Regulations issued there under besides taking legal action under Section 188 of the IPC and other legal provisions as applicable.

And whereas, it is observed that the number of COVD-19 positive cases are showing increasing trend in some districts of the State;

And whereas, COVID appropriate behavior and protocols are required to be observed scrupulously in order to prevent the transmission of the infection;

Therefore, with a view to ensuring strict social distancing and isolation to contain the spread of COVID-19 pandemic, the Government of Odisha in Revenue & Disaster Management (Disaster Management) Department, in exercise of the powers conferred under Section 24(I) of the Disaster Management Act, 2005 read with Rule 8(1) of the Odisha Disaster Management Rules,2010, do hereby issue the following directions (to Collector Balasore, Mayurbhanj & Jharsuguda):

- 1. Collectors of Balasore, Mayurbhanj are hereby directed to put Border Check Posts (BCP) onall inter-State roads (NH, State roads and local roads) along West Bengal border with immediate effect.
- 2. The District Administrationsshall ensure border tracking for all the major and minor entry points for incoming people from State of West Bengal adjoining their districts. Adequate police arrangement may be made for such tracking.
- Anyone coming to Odisha from West Bengal by personal / hired vehicles (two-, three- or Four-wheelers) or entering the state in any other mode shall undergo mandatory institutional/ paid quarantine for 14 days in Cluster TMC to be managed by BDO/ EO of Urban areas.
- 4. The District Administrations shall ensure appropriate facilities and logistic support to Cluster TMC. Such TMCs shall be operated as per guidelines of SRC office.
- 5. People travelling from West Bengal to other States through Odisha shall be allowed without disembarking from the vehicle en-route inside Odisha.
- 6. Sarpanch(s)/ Ward Member (s) of PRIs & volunteers shall be mobilised to create awareness in their areas and further report to BDO/Police Station/ Local Authorities about any person coming from West Bengal not quarantined in institutional facilities.

- 7. All passengers coming from West Bengal alighting at Bhubaneswar/ JharsugudaAirport shall be mandatorily subjected to institutional quarantine/ paid quarantine for 14 daysat facilities identified /ordered by District Magistrate/ Municipal Commissioner or any officer duly authorised on his/her behalf.
- 8. Any person who has been successfully vaccinated (two doses) and produces certificate to the effect or tested Negative (-ve) in RTPCR test (report to be produced) within 48 hours of entering Odisha, may be allowed home quarantine for 14 days. However, in case of non-compliance of the Covid protocols and Home quarantine guidelines issued by MoHFW/ H&FW Department of Government of Odisha, such persons shall be quarantined in institutional facility for fourteen (14) days.

Any person violating these measures will be liable to be proceeded against in accordance with the provisions of Section 51 to 60 of the Disaster Management Act, 2005, the Epidemic Diseases Act, 1897 and Regulations issued thereunder besides taking legal action under Section 188 of the IPC and other legal provisions as applicable.

In view of increase in COVID-19 positive cases and in consonance with the Order No 1663/R&DM(DM) dated 31-03-2021 of Govt of Odisha in Disaster Management Department, the following guidelines are hereby issued for strict adherence at Biju Patnaik International Airport(BPIA).

- 1. The Submission of RT-PCR negative report is compulsory for de-boarding at Biju patnik International Airport.
- 2. All the passenger de-boarding at BPIA for Bhubaneswar to produce the RT-PCR negative reports which must have done maximum 72 Hrs prior to landing at Bhubaneswar.
- 3. Those passengers who have taken two doses of Vaccination can prodiuce the final dose vaccination certificate in lieu of RT-PCR report.
- 4. The Director BPIA to ensure adherence of the above guideline strictly.
- 5. This will come into effect from 20-04-2021 until further order.

<u>ORDER</u>

Whereas, resurgence of SARS-CoV 2 has been noticed in many parts of India and some areas of the State;

And whereas, COVID appropriate behavior and protocols are required to be observed scrupulously in order to prevent the transmission of the infection;

And whereas, the Government of Odisha in Revenue & Disaster Management (Disaster Management) vide its Order No.1663/R&DM(DM) dt.31.03.2021,1708/R &DM(DM) Dt.01.04.2021 and 1714/R &DM(DM) dt.03.04.2021 has issued stipulations in the interest of general public and for containment of COVID-19;

And whereas, the Government of India in the Ministry of Home Affairs, Government of India (GoI) has issued guidelines vide Order No. 40-3/2020-DM-I(A) dated 23rd March,2021 for effective control of COVID-19 with effect from April 1st, 2021;

And whereas, it is observed that the number of COVD-19 positive cases are showing increasing trend in some districts;

Now, therefore, in exercise of the powers conferred under Section 24(I) of the Disaster Management Act, 2005 read with Rule 8(1) of the Odisha Disaster Management Rules, 2010, the State Government do hereby promulgate the following stipulations in the State of Odisha with immediate effect:

- 1. People coming to Odisha by any public transport like train, bus, aeroplane, or water ways etc. or by any private vehicles have to produce RT-PCR negative report obtained within 72 hrs of entry / final vaccination certificate (after two doses of vaccination).People coming without such report shall have to undergo 7 days mandatory Home/ Institutional quarantine.
- 2. Collectors of the following Districts namely Sundargarh, Jharsuguda, Sambalpur, Bargarh, Balangir, Nuapada, Kalahandi, Nawrangpur, Koraput, Malkangiri, Ganjam, Gajapati, Rayagada, Keonjhar, Mayurbhanj and Balasore are authorised to set up and operationalise Temporary Medical Centres (TMCs)/ Cluster Temporary Medical Centres (CL TMCs) as per requirement for providing

institutional quarantine facilities for people coming from other States. Expenditure for opening and running of such facilities shall be borne under Chief Minister's Relief Fund (CMRF).

- 3. All Public Transport from Odisha to Chhatisgarh and vice versa shall be suspended forthwith till 30th April, 2021. Transport Commissioner , Odisha shall issue appropriate orders in this regard. Transport Department with help of State Police and under active guidance of District Collectors will set up Border Check Points (BCPs) at strategic locations/ border entry points to manage entry of incoming persons/ vehicles.
- 4. Persons coming through the BCPs shall have to produce Final Vaccination certificate/ RT-PCR negative report obtained within 72 Hours prior to the entry to the State or else they will be put in Home/ Institutional quarantine for 7 days. The incoming persons shall have to give an undertaking to this effect and submit filled in form containing the name of the person, from where coming, the address of destination, Mobile number and alternate contact number.
- 5. All Industries/ Educational Institutions/ Commercial Establishments shall ensure implementation of all COVID appropriate behaviour/ protocols and set up their own isolation facilities i.e Covid Care Centres (CCCs)/ Covid Care Homes (CCHs) for Covid Positive persons found in their Establishments. The Expenditure incurred for this purpose shall be borne by them. All such Institutions shall identify Covid Compliance Officer among their senior staff, who shall ensure the implementation of Covid Compliance Guidelines/ protocols within their premises and submit daily report to the Collector/ Municipal Commissioner. If any violation is observed in complying with Covid-19 appropriate behavior and protocols, they will be liable to be proceeded against in accordance with the provisions of section 51 to 60 of the Disaster Managemnet Act, 2005, the Epidemic Diseases Act, 1897 and Regulations issued thereunder besides legal action under section 188 of the IPC and other legal provisions as appliacable.
- 6. All Collectors/ Municipal Commissioners shall have regular meetings with the Industries/ Educational Institutions/ Commercial Establishments within their jurisdiction to sensitize them to follow Covid appropriate behavior and ensure strict adherence of Covid safety protocols such as wearing of masks, maintaining social distancing and provision of thermal scanning & use of hand wash or sanitizer.

All Collectors/ All Superintendents of Police/ All Municipal Commissioners/ Commissioner of Police, Bhubaneswar- Cuttack are hereby directed to ensure the implementation of this guideline.

Any person found violating this order shall be punished under the provisions of the Disaster Management Act, 2005 and other relevant laws.

Precautionary measures at Airports and Railway Stations to prevent Sub: spread due to upsurge of COVID-19 infection in some States-Reg.

Madam/Sir,

In continuation to this Department letter No. 6155/H dated 27.02.2021 on the subject cited above, you are requested to take necessary steps to conduct mandatory Rapid Antigen Test of all passengers coming from the 5 high risk States namely Maharashtra, Kerala, Punjab, Madhya Pradesh and Chhattisgarh on arrival.

Further, the mandatory Rapid Antigen Test for arrivals from the 5 high risk States can be dispensed with for asymptomatic passengers who have a RT-PCR Negative report (done not more than 72 hours before boarding) or a Covid Vaccination Final certificate.

This may be treated as **Extremely Urgent**.
