**Sub: Restrictions on incoming flights to West Bengal-reg.**

Sir,

The restrictions on incoming flights to West Bengal have been reviewed and in view of the improved COVID situation, it has been decided that:

(i) There shall be no restrictions on incoming flights from any location in the country (except Bangalore) subject to the condition that the passengers are either fully vaccinated or RT-PCR Test conducted within 72 hours from the time of departure.

However, the incoming domestic flights from Bangalore shall be allowed thrice a week on Monday, Wednesday and Friday and the same will be reviewed again depending upon the COVID situation.

(ii) Further, incoming flights to Kolkata from United Kingdom are also hereby allowed subject to RT-PCR Test conducted within 48 hours prior to departure and on arrival to Kolkata as per the extant norms.

These shall come into effect from 1<sup>st</sup> February, 2022.

It is kindly requested that all airlines may be communicated of the aforesaid decision of the State Government for necessary action.
